Chronic illness is costly—data shows that about 30% of emergency department visits made by people living with chronic illness are unnecessary, leading to \$8.3 billion in additional costs to the healthcare market. The CCM program had such a positive impact on patients, that CMS enhanced its Remote Care Management models to include Remote Patient Monitoring (RPM) and Behavioral Health Integration (BHI) in 2018.

What is the difference between the Care Models?

Medicare patients with one chronic condition qualify for RPM, while patients with two or more chronic conditions qualify for CCM as well. Patients with either a mental health diagnosis or substance abuse diagnosis qualify for BHI. These chronically ill patients often need more attention and follow-up to ensure they are following their comprehensive care plan.

All three of these models are value-based care programs developed for Medicare beneficiaries who have chronic conditions and were developed to promote better healthcare through early intervention, reduce the burden of costly ER visits and hospital admissions, promote patient engagement in their care journey, and reduce overall care costs.


